
Buying Pressure persisted in The Nigerian Fixed Income market as higher prices quoted on the exchange moved yield further southwards in the month of January 2023. Average yield on the Nigerian Treasury bill secondary market fell to 1.82% from 5.29% the previous month as yield on all bills nosedived over the month. Yield on the 26 October 2023 and 9 November 2023 compressed by 559bps and 446bps respectively, to 1.53% and 3.57%.

Average NTB Primary Market Auction stop rate was 4.42%, compared to the previous month of 7.56%, as the stop rate for 91day, 182 days and 364 day closed at 0.29%, 1.80% and 4.79% respectively. A total of ₩220.53Bn was offered across the tenor while ₩1.04Tn was allotted.


