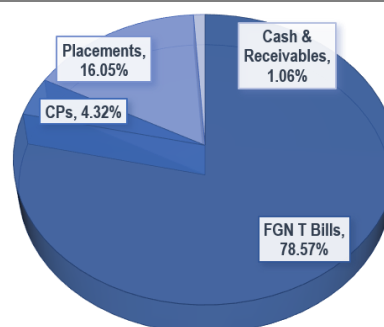
Review and Outlook

- Yields on treasury bills inched up by 14bps on average over the month from 12.74% as at 28 February 2019 to 12.88% as at 31 March. The increase was more pronounced in the 1M and 6M yields which rose by 131bps and 101bps respectively. 12M yields dropped by 120bps. 13—165 day Commercial Papers yielded 13.78% on 31 Mar, vs. 12.36% yield on T-Bills with similar maturities on the same day.
- The March 2019 T-bill position represents a reversal after 2 consecutive months of decrease from an average of 15.26% as at 31 Dec 2019. Inflation figures for February 2019 were released during the month, showing a further decline in YoY headline inflation to 11.31% from 11.37% in January, driven by both core and food indices. The MPC cut policy rate by 50bps from 14% to 13.5% after a broad scope of macroeconomic considerations.

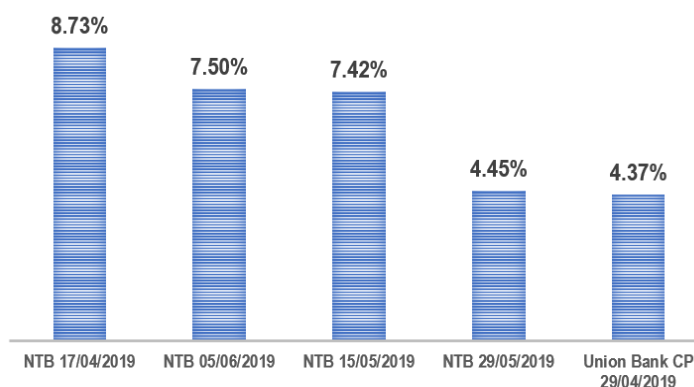

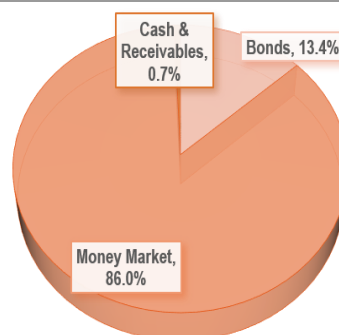
Review and Outlook

- Yields on treasury bills inched up by 14bps on average over the month from 12.74% as at 28 February 2019 to 12.88% as at 31 March. The increase was more pronounced in the 1M and 6M yields which rose by 131bps and 101bps respectively. Corporate Bonds yielded 15.73% on 31 Mar, vs. 14.13% yield on FGN Bonds with similar maturities on the same day.
- The March 2019 T-bill position represents a reversal after 2 consecutive months of decrease from an average of 15.26% as at 31 Dec 2019. Inflation figures for February 2019 were released during the month, showing a further decline in YoY headline inflation to 11.31% from 11.37% in January, driven by both core and food indices. The MPC cut policy rate by 50bps from 14% to 13.5% after a broad scope of macroeconomic considerations.

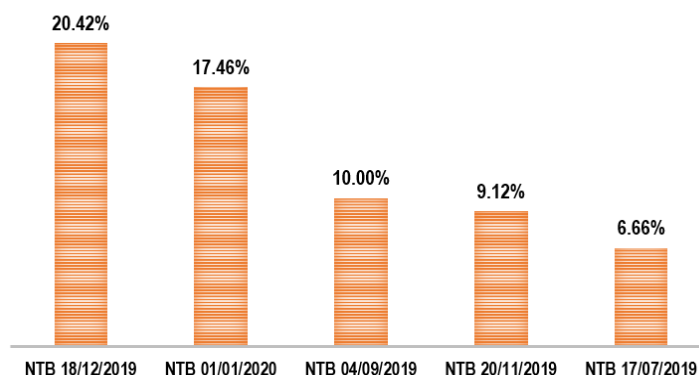

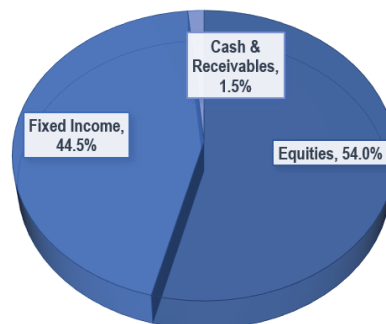
Review and Outlook

- The NSE All Share Index (ASI) lost 2.14% in March 2019, closing at 31,041.42 from 31,718.70 at the start of the month. The decrease in the ASI was led by the Insurance and Oil & Gas sectors which declined by 5.47% and 2.71% respectively. 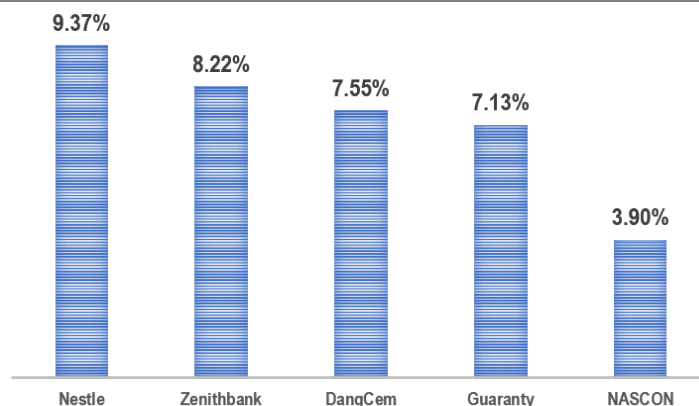

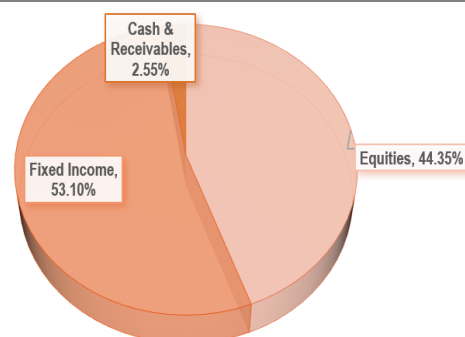

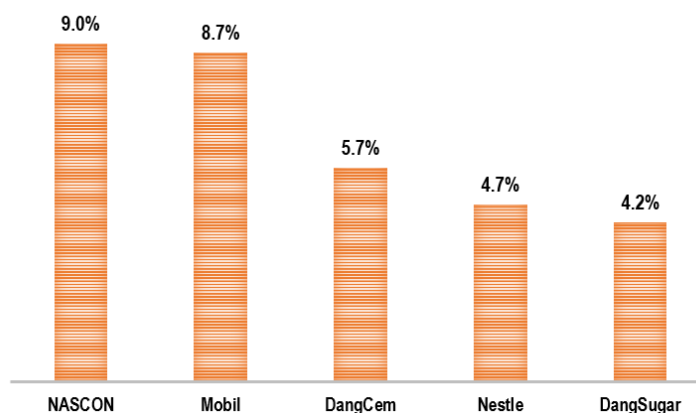
