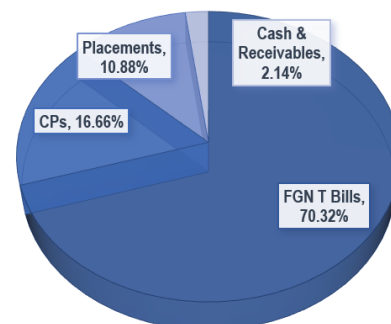
### Review and Outlook

- Yields on treasury bills rose by 251bps on average over the month from 10.93% as at 31 July 2019 to 13.45% as at 31 August. The increase was evenly spread across the yield curve, with 3M and 12M yields rising by 296bps and 234bps respectively. Commercial Papers yielded 14.62% on 31 August, vs. 13.36% yield on T-Bills with similar maturities on the same day.
- The August 2019 T-bill position represents a reversal after a drop in July 2019. Inflation figures for July 2019 were released during the month, showing a decrease in YoY headline inflation to 11.08% from 11.22% in June, driven more by food and minimally by core inflation. The Nigerian fixed income and money market is currently offering a positive real return which improved over the month with the higher yields and lower inflation.

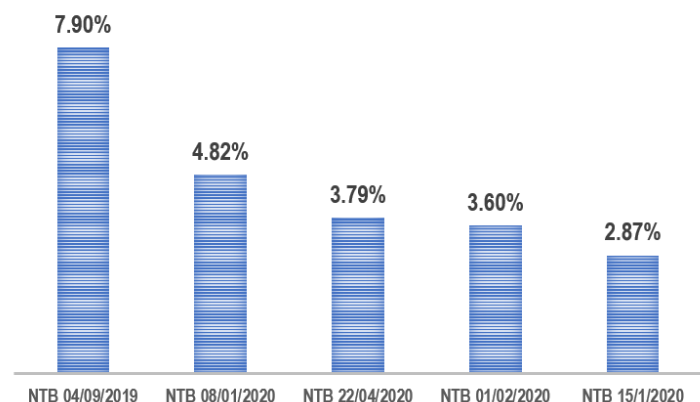

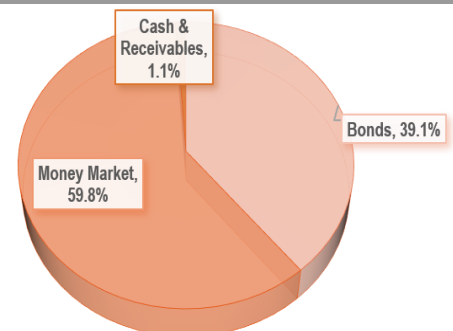
### Review and Outlook

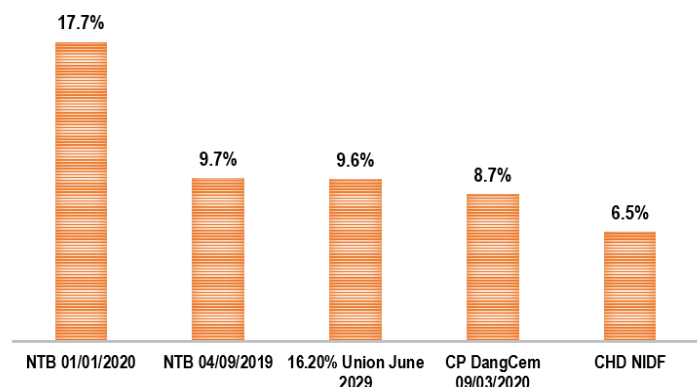

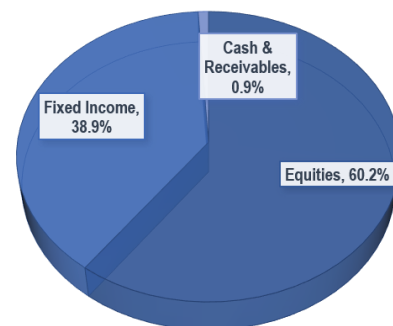
### Review and Outlook

- The NSE All Share Index lost 0.69% in August 2019, closing at 27,525.81 points from 27,718.26 at the start of the month. The decrease in the ASI was led by the oil & gas and insurance sectors, which declined by 12.16% and 7.68% respectively. The oil & gas sector decline was driven by Seplat (-18.84%) and Forte Oil (-16.28%), while Continental Re (-24.08%) and NEM Insurance (-11.63%) led the insurance sector decline.
- 5.1 billion shares worth N62.0bn were traded in August 2019, up from 4.7 billion shares worth N56.0bn traded in July 2019. The NSE ASI performance in August was less bearish than the MSCI emerging and frontier markets indices, which lost 2.7% and 1.6% respectively over the month. The downward trend in the NSE ASI seems to persist, as the 12 month chart shows the index recording lower consecutive support levels.

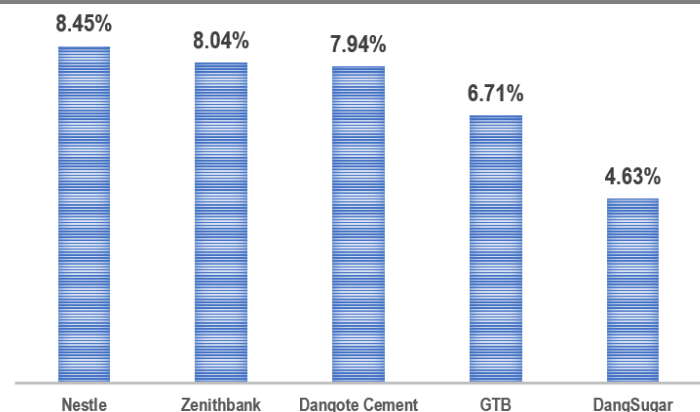

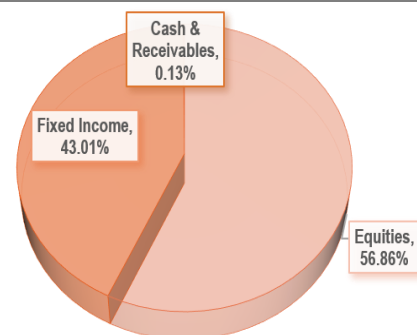

- The NSE All Share Index lost 0.69% in August 2019, closing at 27,525.81 points from 27,718.26 at the start of the month. 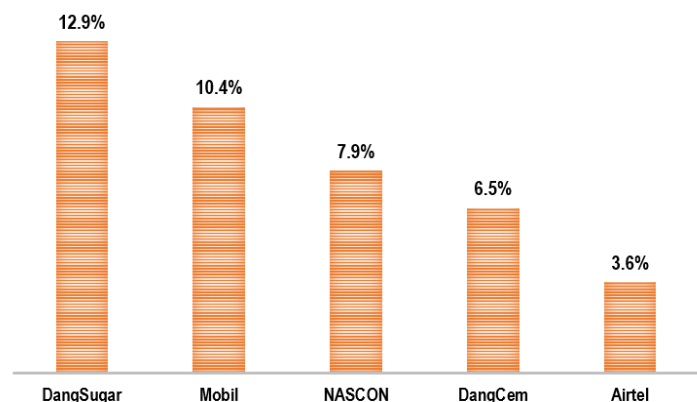
