## **TERMS & CONDITIONS**

The General Terms and Conditions set out below, together with the Customer's account application forms (the "Forms") and General Terms and Conditions may be amended from time to time) shall constitute the entire agreement under which the Customer's Account will be managed by Quantum Zenith Asset Management & Investment Limited (QZAML).

## 1. Account Opening and Management.

## 6. Approval of Statements.

Any objection to a statement of account or report on investment issued to the Customer by QZAML must be made in writing upon receipt of the same and must reach QZAML no later than two weeks from the date on which the statement or report was sent by QZAML.
