MARKET COMMENTARY

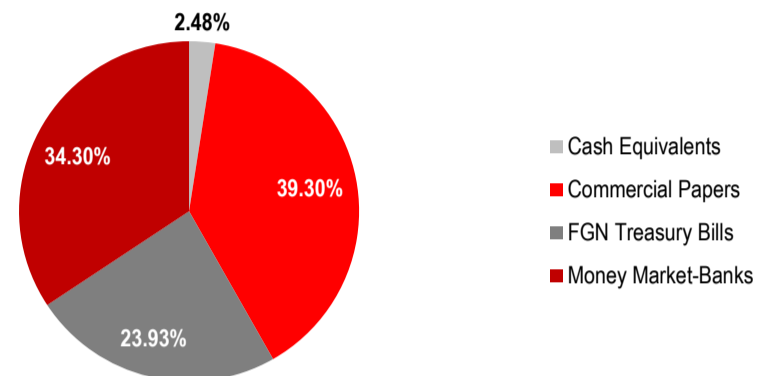
Investors' interest in the Nigerian Treasury Bills secondary market rose in the month of May, as quoted prices on securities rose, thereby pulling yields lower. Average yield nosedived by 84bps to close at 5.84%, down from 6.68% for the previous month. Yield on the 8 June 2023 and 7 September 2023 contracted by 230bps and 102bps respectively, to 3.23% and 4.49%.

Average NTB Primary Market Auction stop rate was 5.87%, compared to the previous month of 8.70%, as the stop rate for 91day, 182 days and 364 day closed at 2.29%, 4.99% and 8.99% respectively. A total of ₦180.45Bn was offered across the tenor while ₦180.45Bn was allotted.

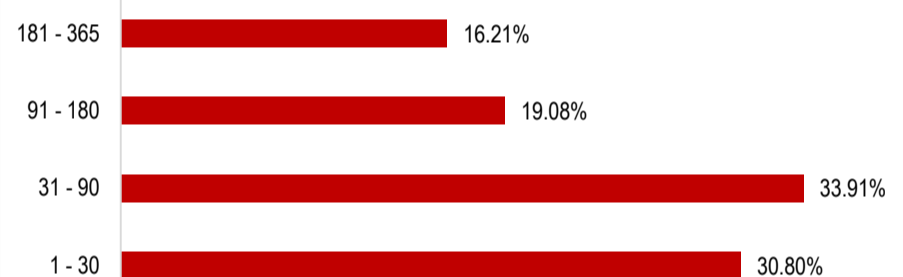
The annual inflation rate in Nigeria accelerated for the fifth month to 22.22% in April 2023, reaching a nearly 18-year high and following 22.04% in the prior month.

The Central Bank of Nigeria raised its benchmark interest rate by another 50 bps to 18.5% in a decision announced on May 24th 2023, as widely expected. It marks the third consecutive rate hike so far this year, bringing borrowing costs to their highest since the monetary policy rate was adopted in 2006. The decision was driven by continued upside risks to the inflationary outlook and the further acceleration of inflation through April.

MARKET COMMENTARY

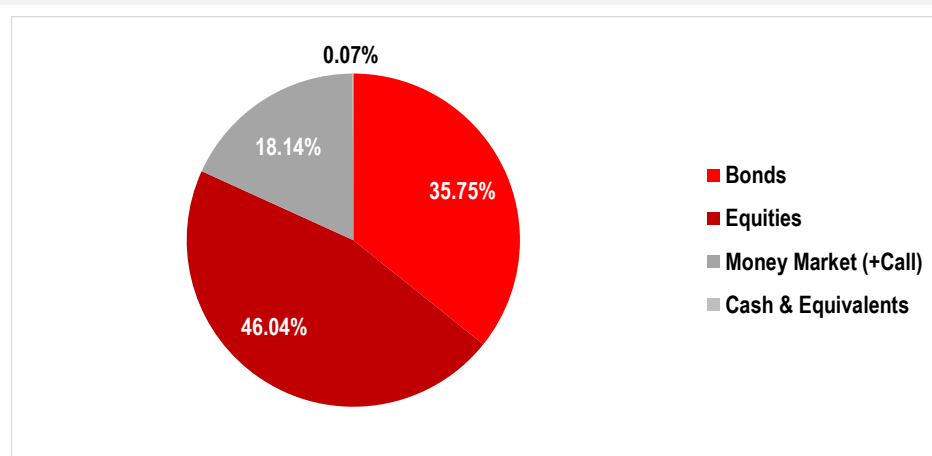

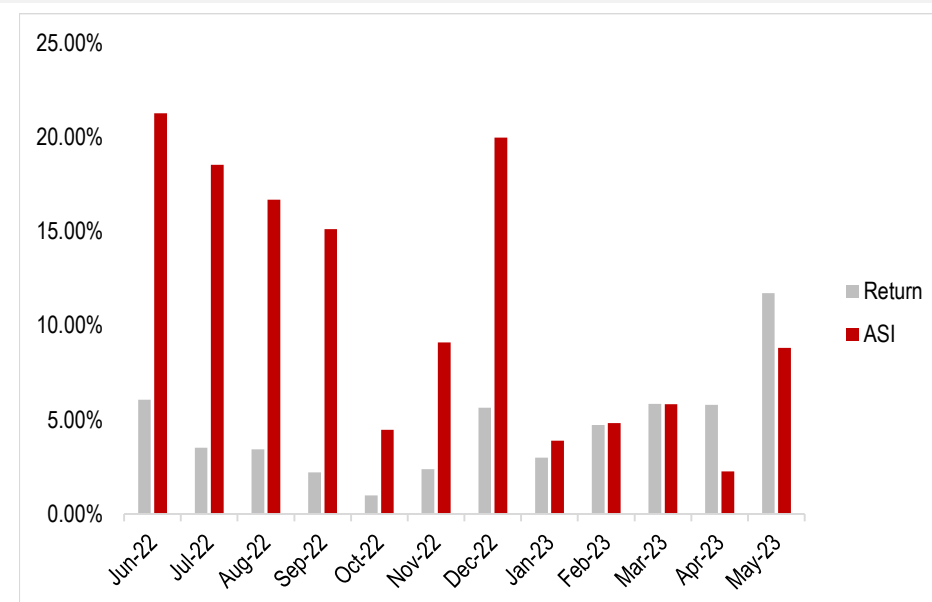

EQUITY SECTORAL ALLOCATION

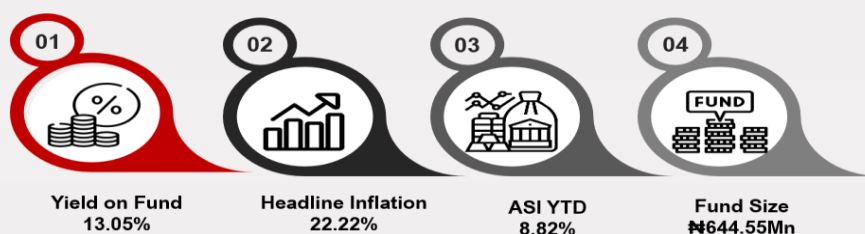
