
In the month of June, bearish sentiments ruled the Nigerian Treasury Bills secondary market as yields on securities expanded due to lower quoted prices in the market, resultantly average yield increased by 14bps to 21.86% from 21.72% in the previous month. This was due to the introduction of the 08 May 2025 bill which closed at 25.75%.

Average NTB Primary Market Auction stop rate was 18.15%, compared to the previous month stop rate of 18.10%, as the stop rate for 91 day, 182 day and 364 day closed at 16.30%, 17.45% and 20.68% respectively. A total of ₩494.08Bn was offered across all tenors, while ₩606.92Bn was
