
In the Month of September, the bears resurfaced in the Nigerian Treasury Bills secondary market as yields on securities expanded due to lower quoted prices on securities, Consequently average yield surged by 45bps to 21.90% from 21.45% in the month August. This was due to the introduction of the 07 August 2025 and 04 September 2025, which closed at 22.58% and 21.35% respectively.

Average NTB Primary Market Auction stop rate was 17.80%, compared to the previous month stop rate of 19.70%, as the stop rate for 91 day, 182 day and 364 day closed at 17.00%, 17.50% and 20.00% respectively. A total of N622.73Bn was offered across all tenors, while N622.73Bn was allotted.

Nigeria's year on year headline inflation rate decreased by 125bps to 32,15% in August 2024, down from 33,40% in July 2024.

The Central Bank of Nigeria (CBN) reviewed the benchmark interest rate (MPR) upwards by 50bps to 27.25% from 26.75% in the meeting held in September 2024. The Cash Reserve Ratios (CRR) of Deposit Money Banks and Merchant Banks were raised to 50.00% (prev. 30.00%) and 16.00% (prev. 14.00%) respectively. The Asymmetric corridor was retained at +500/-100 basis points from -300/+100 basis points and the Liquidity Ratio (LR) was kept at 30.00%.


ASSET ALLOCATION 2.27% Money Market - Banks FGN Treasury Bills Commercial Papers Cash Equivalents
